## **Call for Speakers**

### **Basic information**

The duration of each presentation is 15 minutes.

The deadline for submissions is Friday, **May 2nd, 2024** (23:59 Berlin time, standard time zone: GMT/UTC + 01:00).

The focus is on giving courageous and practical projects the attention they deserve. The Call for Speakers is therefore aimed at:

- Professionals from all disciplines and all levels of the public sector
- Researchers from universities, institutes and think tanks

With this Call for Speakers, we are looking for practical contributions that stimulate discussion of the topic and enrich the knowledge of the participants. We kindly ask you to refrain from marketing presentations.



## **Scope & content**

- The synopsis is limited to 1,000 characters including spaces.
- The title should be short and meaningful, max. 100 characters including spaces).
- The summary should outline the problem, describe the solution or idea, explain the practical benefits and relevance for the public sector.
- The practical relevance of the contributions is a focal point and therefore an important factor for the evaluation of the exposés.

Submissions may cover the following topics, but are not limited to them:

- Cloud solutions and IT infrastructure
- Digital justice
- Digital participation and accessibility
- Digital administrative services
- Skilled workers and digital skills
- Al and data economy
- Municipal best practices
- Mobility & energy
- Sustainability
- State sovereignty and cyber security
- Transformation of procurement
- Networking technologies

Papers can be submitted and presented in German and English.
